Complete Choice Unlimited Competitive Acquisition Extension FL 2006-188

Overview

In accordance with the special promotions section of the appropriate General Subscriber Services Tariff or General Exchange Price List, BellSouth plans to extend the following promotion. The Complete Choice Unlimited Competitive Acquisition Extension promotion is extended beginning 10/26/2006 and ending on 12/31/2007.

Promotion Specifics

Acquisition customers will be offered Complete Choice with a Bellsouth Unlimited plan. These customers will also have the choice of optional free voice mail service when subscribing to this bundle. Any qualifying residential customer who purchases BellSouth Complete Choice service, BellSouth Long Distance Unlimited service, and BellSouth Voice Mail Premium service under this promotion will be eligible to receive a discount on their BellSouth Complete Choice service monthly recurring charge in the amount of \$5.00, and a discount on their BellSouth Voice Mail Premium service monthly recurring charge in the amount of \$3.95.

Program Eligibility

- 1. Customer must have at least one (1) wireline local service or equivalent (wireless in lieu of wireline) with a provider other than BellSouth at a local service address within the territory.
- 2. The customer must select BellSouth as their local service provider.
- 3. Customer must request the qualifying service at the same address and in the same name as the existing service, unless customer is planning an imminent move from one address in BellSouth territory to another address in BellSouth territory within thirty (30) days of responding to the offer.
