Overview

The BellSouth Line Connection Waiver Promotion is available only to BellSouth business customers with a new location who currently have local exchange service with another exchange provider and who subscribe to BellSouth local exchange service.

This tariff revision is provided to clarify the Promotion Element that requires a subscriber to purchase a minimum of one (1) line per each *new* location to be eligible and maintain that level of service for a minimum of four (4) months.
