
STATEMENT OF ISSUES

(2) Whether Caller ID as proposed by Southern Bell Telephone and Telegraph Company violates Chapter 934, Florida Statutes (1989), the Florida Wiretap Act;

(3) Whether Caller ID as proposed by Southern Bell Telephone and Telegraph Company violates the Constitution of the State of Florida.
