PURPOSE AND PROCEDURE

The purpose of this hearing shall be to receive testimony and exhibits concerning Florida Power Corporation's proposed acquisition of the electric distribution and transmission system of Sebring Utilities Commission. The Public Service Commission will consider the joint petition for approval of an amendment to Florida Power Corporation's and Sebring Utility Commission's territorial agreement; the depreciated net book value and any going-concern or franchise value of Sebring's assets; a separate rate and rate schedule for Sebring's customers to be acquired by Florida Power Corporation; the assignment of Sebring's territorial agreement with Glades Electric Cooperative to Florida Power Corporation, the prudence of Florida Power Corporation's proposed investment; and recovery of capacity costs associated with the Sebring Utilities Commission's Power Purchase Agreement with Tampa Electric Company.

PRACTICE AND PROCEDURE


