# CASE BACKGROUND

Order PSC-94-0696-FOF-TL requires Central Telephone Company (Centel) to discontinue providing centrex service for residential resale to Royal Oaks Apartments and "other entities that is being provided under the same circumstances..." To reduce inconvenience to the residents of these entities, the Commission's order allowed them the option of remaining on centrex service until August 7, 1994. Staff chose this date because most residents are students and Florida State University's last day of summer semester is Friday, August 5th. However, staff has recently learned that the last day of final exams for the semester is Friday, August 12th. Leases for many of the affected entities also coincide with this date. To avoid a disruption in service for those residents who are on this lease period, staff wishes to allow Centel to continue providing the service through Monday, August 15, 1994.

## DISCUSSION OF ISSUES

ISSUE 1: Should Central Telephone Company be allowed to continue providing centrex service to the entities affected by Order PSC-94-0696-FOF-TL until August 15, 1994?

## RECOMMENDATION: Yes.

STAFF ANALYSIS: Order PSC-94-0696-FOF-TL specified August 7, 1994, as the date through which Central Telephone Company could continue providing centrex service to affected entities. The majority of residents at these affected entities are university students whose last day of final exams is August 12, 1994. To avoid a disruption in telephone service to residents using centrex service, staff recommends that the Commission allow Centel to provide the service for an additional eight days, until August 15, 1994.

Staff believes allowing this additional time is reasonable and prudent and will not thwart the purpose of the Commission's order in any way.

### ISSUE 2: Should this docket be closed?

RECOMMENDATION: Yes, this docket should be closed upon issuance of the final order.

<u>STAPF ANALYSIS:</u> This docket was set to be closed when the original proposed agency action order was final. However, with the Commission's adoption of Issue 1, this docket should be closed upon issuance of the final order.
