 TUESDAY. PLEASE HELP TO KEEP THE AREA CLEAN.
- YOU ARE RESPONSIBLE FOR KEEPING AN AREA OF FIVE FEET AROUND YOUR TRAILER CLEAN AND NEAT.
- 3. NO CHANGES OR ADDITIONS TO YOUR TRAILER WITHOUT PERMISSION FROM THE MANAGEMENT.
- 4. PETS MUST BE KEPT ON A LEASH, AND OWNERS ARE REQUIRED TO PICK UP THEIR PETS' DROPPINGS.
- 5. IF YOU HAVE OVERNIGHT GUESTS FOR MORE THAN A TOTAL OF TWO WEEKS PER YEAR, A FEE OF \$1.00 PER PERSON PER NIGHT WILL BE CHARGED.
- 6. FIRE TAX IS DUE NOVEMBER 1ST OF EACH YEAR.
- 7. CLOTHES LINES ARE NOT PERMITTED AROUND YOUR TRAILER. PLEASE USE LINES PROVIDED.
- 8. WHEN A TRAILER IS REPLACED WITH ANDTHER TRAILER, IT MUST HAVE SKIRTING AND TIE-DOWNS.
- 9. UNDERNEATH TRAILERS MUST BE KEPT CLEAN AND FREE OF ANY AND ALL ARTICLES.
- 10. THE PUBLIC WASHROOMS ARE FOR THE USE OF ALL PARK RESIDENTS AND THEIR GUESTS.
- 11. THE TELEPHONE IS AVAILABLE FOR YOUR USE IN THE RECREATION HALL. PLEASE WRITE DOWN YOUR LONG DISTANCE CALLS.
- 12. TRAILERS CANNOT BE SOLD IN THE PARK WITHOUT PERHISSION FROM THE MANAGE-MENT. PERSONS BUYING A TRAILER IN THE PARK MUST CHECK WITH THE MANAGE-MENT BEFORE THEY MAY RENT A LOT.
- 13. EACH TRAILER MAY BE OCCUPIED BY NO MORE THAN TWO PERMANENT RESIDENTS, OVER THE AGE OF 55.
