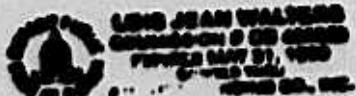

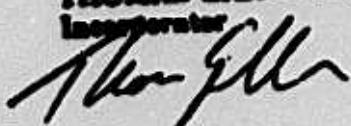


ARTICLE II - AMENDMENT

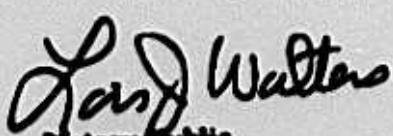
