In response to your questions regarding nonused and nonuseful plant, water and sewer, for both Sunray - Nassau and Sunray - St. Johns, I am providing the following information.

I. Please provide the methodology or the estimation procedures used to determine the nonused and useful plant amounts contained in the 1995 Sunray - St. Johns Annual Report. Prior to the 1995 Annual Report, an estimation of the nonused and useful plant was not requested or required. When the revised report was issued by the St. Johns County Water and Sewer Authority, I contacted the Authority for some assistance as to how to calculate the nonused and useful plant, if any. No one could provide an answer other than to say, "just estimate it." Therefore I strongly believe that the amounts contained within the report should not be construed as precise or binding as I do not possess the qualifications necessary to determine nonused and useful plant. Accurate nonused & useful amounts, if any, are to be calculated by a qualified engineer.
