This is to inform you that Omni Communications, Inc., 4114 Northlake Blvd., Suite 301, Palm Beach Gardens, Florida 33410 ("Omni"), granted certification as a telecommunications carrier by Order No PSC-93-1116-FOF-TI dated August 24, 1993 in Docket No. 930477-TI, has had a change in control of ownership. On January 22, 1997, Omni was merged into USLD Acquisition Corp. II, ("Acquisition Corp") a Texas corporation, which will operate in Florida as USLD Acquisition Corp.
