PETITION FOR APPROVAL OF  
ENVIRONMENTAL COST RECOVERY FACTORS  
FOR PERIOD OCTOBER 1998 THROUGH DECEMBER 1998

Florida Power & Light Company ("FPL"), pursuant to Order No. PSC-93-1580-FOF-EI and Order No. PSC-98-0691-FOF-PU approving a change to a calendar year basis for Environmental Compliance Factors effective January 1999, hereby petitions this Commission for authorization to extend its currently approved Environmental Compliance Factors for the period October 1998 through December 1998 and to allow prior period true-up amounts to be reflected in the calendar year 1999 period.

In support of this Petition, FPL incorporates the prepared written testimony of and documents sponsored by Ms. K.M. Dubin and states:

1. Florida Statutes Section 366.8255, which became effective on April 13, 1993, authorizes the Commission to review and approve the recovery of prudently incurred Environmental Compliance Costs.

2. In connection with the Commission's change to a calendar year basis for the Environmental Cost Recovery Clause, effective January 1, 1999 there is a three month period, October 1998 - December 1998, which needs to be addressed because the current factor ends September 1998.

3. As set forth in the testimony of Ms. K.M. Dubin FPL

requests that the factor for this three month period not be separately set based upon a projection of costs for that three month period. Instead, FPL requests authorization to continue the currently authorized factors for the remainder of 1998.

4. In its January 2, 1998 petition for approval of final Environmental true-up amounts FPL requested that the amounts be carried forward to the October 1998 through September 1999 period. FPL now petitions the Commission to allow true-up amounts to be carried forward to the annual period of January 1999 - December 1999.

WHEREFORE, FPL respectfully Petitions for authorization to extend its currently approved Environmental Compliance Factors for the period October 1998 through December 1998 and to allow prior period true-up amounts to be reflected in the calendar year 1999 period.
