
AMENDED MOTION FOR ADDITIONAL TIME

Comes now Amer-I-Net Services Corp. ("Amer-I-Net") and files this Amended Motion for Additional Time. As basis, Amer-I-Net would state:

1. By Order No. PSC-98-0549-SC-TI issued April 20, 1998 this Commission issued a show cause order to Amer-I-Net for alleged violations of Rule 25-4.118, Florida Administrative Code. On May 7, 1998 the Commission granted an extension of time to respond to the show cause order.

2. On June 19, Amer-I-Net requested 5 additional work days to respond to the order or file a settlement proposal. This motion is pending. Amer-I-Net has not obtained final approval of the proposal but expects such approval to be provided by June 30. In the meantime, Amer-I-Net has conveyed the contents of the draft proposal to Staff for their analysis. Under these circumstances Amer-I-Net would amend its Request for Additional Time to request until June 30 to submit a proposal or response.


