

A RESOLUTION OF THE CITY OF WEST MELBOURNE, BREVARD COUNTY, FLORIDA, OPPOSING THE NEW OVERLAY AREA CODE FOR BREVARD COUNTY AND INFORMING THE PUBLIC SERVICE COMMISSION OF THE CITY OF WEST MELBOURNE'S OPPOSITION; PROVIDING AN EFFECTIVE DATE.

A RESOLUTION opposing the new overlay area code for Brevard County and urging the Public Service Commission to reconsider the new overlay area code.

WHEREAS, this new area code would include the area served by area code 561; and

WHEREAS, the Brevard County Board of County Commissioners approved the request of a single new area code for the entire County; and

WHEREAS, the preference of the Brevard County Board of County Commissioners is to have area code 407.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF WEST MELBOURNE, BREVARD COUNTY, FLORIDA, that:

Section 1.

The City Council of the City of West Melbourne is opposed to the proposed new overlay area code for Brevard County.


Section 2.
