Issue 2: On what date should Gulf's proposed Standard Offer Contract become effective?

Recommendation: Gulf's Standard Offer Contract should become effective on December 1, 1999.

Recommendation: Yes. If a protest is filed, the tariffs should remain in effect pending resolution of the protest. Because the tariffs do not require the delivery of any capacity until June 1, 2002, any protest will be resolved prior to the performance date.


