ORDER TO SHOW CAUSE

Respondent, Florida Power & Light Company's Motion to Dismiss and for Sanctions was filed on February 21, 2000. The Petitioner did not comply with the Order Requiring Status Report entered January 31, 2000; and the Petitioner did not file a response in opposition to the instant motion within the time specified in Rule 28-106.204(1), Florida

ORDERED:

1. On or before 5:00 p.m. on March 23, 2000, the Petitioner, David E. Roomes, shall show cause in writing why he has not complied with the October 15, 1999, Order Compelling Responses to Discovery and Canceling Hearing or the January 31, 2000, Order Requiring Status Report.

2. On or before 5:00 p.m. on March 23, 2000, the Petitioner, David E. Roomes, shall show cause in writing why the file of the Division of Administrative Hearings should not be closed and this matter returned to the referring agency.

3. Failure to respond to this order on or before 5:00 p.m. on March 23, 2000, shall result in the closure of the file of the Division of Administrative Hearings and the return of this case to the referring agency without further notice.
