
Orlando Telephone Company (OTC) moves to postpone the hearing scheduled for August 14, 2000, and reschedule the hearing for a time that will be convenient for all of the parties.

OTC requires a postponement because one of its three witnesses, Jerry Locke, has a conflict that can not be avoided. The conflict arose as a result of the most recent hearing date change by the Commission.

The hearing was originally scheduled for January 20, 2000. Due to personnel limitations, the Commission rescheduled the hearing for August 23, 2000. Then, the hearing was rescheduled for August 24, 2000. Then due to the departure of Commissioner Susan Clark, the hearing was recently rescheduled for August 14, 2000. During the time the hearing was scheduled for late August, Jerry Locke, arranged and paid for a vacation that includes August 14, 2000, and changes are not possible to Jerry Locke's plans without a substantial economic penalty.

OTC submits that one more change will not make a significant difference to the parties and requests a hearing date be set for some time in early fall 2000.
