Re: Approval of an Amendment to the Interconnection Unbundling, Resale and Collocation Agreement Negotiated by BellSouth Telecommunications, Inc. ("BellSouth") and Preferred Carrier Services, Inc. pursuant to Sections 251, 252 and 271 of the Telecommunications Act of 1996

Dear Mrs. Bayo:

Pursuant to section 252(e) of the Telecommunications Act of 1996, BellSouth and Preferred Carrier Services, Inc. are submitting to the Florida Public Service Commission an amendment to their negotiated agreement for the interconnection of their networks, the unbundling of specific network elements offered by BellSouth and the resale of BellSouth's telecommunications services to Preferred Carrier Services, Inc. This amendment changes the company's name from Preferred Carrier Services, Inc to Preferred Carrier Services, Inc d/b/a Telefonos Para Todos and d/b/a Phones for ALL.

Pursuant to section 252(e) of the Act, the Commission is charged with approving or rejecting the negotiated agreement between BellSouth and Preferred Carrier Services, Inc. within 90 days of its submission. The Act provides that the Commission may only reject such an agreement if it finds that the agreement or any portion of the agreement discriminates against a telecommunications carrier not a party to the agreement or the implementation of the agreement or any portion of the agreement is not consistent with the public interest, convenience and necessity. Both parties aver that neither of these reasons exist as to the agreement they have negotiated and therefore, are very hopeful that the Commission shall approve their agreement.

**FIRST AMENDMENT  
TO THE

Pursuant to this Amendment (the "Amendment"), Preferred Carrier Services, Inc. ("Preferred") and BellSouth Telecommunications, Inc. ("BellSouth") hereinafter referred to collectively as the "Parties," hereby agree to amend that certain Interconnection Agreement between the Parties dated December 13, 2000 ("Agreement").

WHEREAS, the Parties desire that the Agreement be amended to reflect the correct, certificated name for Preferred Carrier Services, Inc. in the state of Florida.

NOW THEREFORE, in consideration of the mutual promises and covenants contained herein and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Parties hereby covenant and agree as follows:

1. In the state of Florida only, the name Preferred Carrier Services, Inc. ("Preferred") is hereby deleted and replaced with Preferred Carrier Services, Inc. d/b/a Telefonos Para Todos and d/b/a Phones for ALL ("Preferred") in the Preamble and the Signature Lines of the Interconnection Agreement.
2. All other provisions of the Interconnection Agreement dated December 13, 2000 shall remain in full force and effect.
3. Either or both of the Parties is authorized to submit this Amendment to each Public Service Commission for approval subject to Section 252(e) of the Federal Telecommunications Act of 1996.
