Dear Mr. Ramdas:

The Commission received your 2000 Regulatory Assessment Fee (RAF) Return, along with a letter advising that your business closed permanently in July 2000. There was a check in the amount of \$1.80 with the RAF return.

Rule 25-4.0161, Florida Administrative Code, provides that if a certificate is active for any day during a calendar year, the certificate holder owes the RAF for that year. There is a minimum \$50.00 RAF due. This means you have a balance of \$48.20 for the 2000 RAF and \$6.00 penalty and interest balance from the 1999 RAF payment (you paid after the due date).

If you respond by February 20, 2001 by paying the \$54.20, staff will make the effective date December 31, 2000 so that the 2001 fee will not be due. If, however, the \$54.20 is not received by that date, the effective date will be the date we receive the payment and the 2001 fee will be due. If you have any questions, just let me know. 

25-24.514 Cancellation of a Certificate.

- (1) The Commission may cancel a company's certificate for any of the following reasons:
- (a) Violation of the terms and conditions under which the authority was originally granted;
 - (b) Violation of Commission rules or orders;
 - (c) Violation of Florida Statutes; or,
 - (d) Failure to provide service for a period of six (6) months.

(2) If a certificated company desires to cancel its certificate, it shall request cancellation from the Commission in writing and shall provide the following with its request.

- (a) Statement of intent and date to pay Regulatory Assessment Fee.
- (b) Statement of why the certificate is proposed to be cancelled.

(3) Cancellation of a certificate shall be ordered subject to the holder providing the information required by subsection (2).
