Neither the cancellation of their certificates nor the failure to receive their RAFs Return notice for the year 2000 shall relieve these entities from their obligation to pay RAFs for the year 2000.

This means that the 2000 Regulatory Assessment Fee (RAF) is now past due (due date was January 30, 2001). If you owe only the minimum, the total amount due is \$56.00 (\$50.00 fee, \$5.00 penalty, and \$1.00 interest). However, the penalty and interest charges continue to accrue until paid. It should also be noted that any unpaid amounts will be turned over to the Comptrollers Office for further collection efforts.
