Thank you for your letter of May 23, 2001, concerning the notice of transfer that Breeze Hill Utilities posted on the homeowners' bulletin board. It is staff's understanding that the transfer of majority organizational control of Breeze Hill Utilities from Mr. Paul Bieber to Mr. Terrance Hartigh occurred on April 13, 2001. It is also staff's understanding that the transfer was made contingent upon Commission approval, pursuant to Section 367.071(1), Florida Statutes.

Staff has had several recent conversations with Mr. Hartigh and Mr. Bieber in order to expedite the filing of the application for transfer. Mr. Hartigh and Mr. Bieber are currently finalizing the paper work and expect to file the application in about a week. Please be assured that staff will notify you as soon as the application is filed. At that time, staff will be able to confirm whether the application was made contingent upon Commission approval.

Dear Mr. Talbott:

My neighbor, Mr. Charles Sheppard of 147 Breeze Hill, Lake Wales, FI has recently informed me that a notice had been posted on the homeowners bulletin board in the Breeze Hill community that a MR. TERRY HARTIGH purchased the holdings of Bieber Enterprises, Inc. (which include the water and water treatment plants) effective April 13, 2001. This information has been verified by other residents.

It again raises the question of the utilities being operated without "prior" PSC approval and in violation of Section 367.071, Florida Statutes, the same violation that existed between June 13, 1997 and November 3, 1998, which was merely found to be "regrettable".

Please investigate, and if the allegation is confirmed, we would request the following:

a). If the contract for the sale, assignment, or transfer of the utilities was made contingent upon receiving PSC approval, furnish me a copy of the documentation provided by the buyer and seller to the commission to substantiate this claim. (I assume the "document" would be in the public realm).

b). If the above was not provided for, we would request that the PSC take the necessary actions to cancel the application for the proposed sale, assignment, or transfer of the Certificates 598-W and 513-S, or any other operating authority. The imposition of a penalty under Section 367 161 would not be adequate since this would be a repetitive occurrence.
