

BELLSOUTH TELECOMMUNICATIONS, INC., (“BellSouth”), or “Company”) PURSUANT TO Rule 25-4.114(7), Florida Administrative Code, hereby files its final report regarding the calculation of amounts to be refunded to customers as required by Order No. PSC-01-0091-PAA-TL, and states the following.

1. By Order No. PSC-01-0091-PAA-TL dated January 10, 2001, the Florida Public Service Commission (the “Commission”) ordered BellSouth to refund to BellSouth’s customers monies related to shared earnings for 1997. Rule 25-4.114, Florida Administrative Code, requires the Company to report to the Commission the amount of money to be refunded, the amount actually refunded, the amount of any unclaimed refunds and the status of any such unclaimed refunds. Attached hereto as Attachment “A” is the required information for the final report for the refund.

WHEREFORE, BellSouth files this final report regarding the Florida Refund Calculation.
