On August 10, 2001, the Commission received your letter dated August 8 requesting cancellation of your pay telephone certificate. Rule 25-24.514, Florida Administrative Code. provides that when requesting cancellation of a certificate, a company must either pay the current year's Regulatory Assessment Fee (RAF) or provide a date certain it will be paid. Therefore, enclosed is the 2001 RAF return form. The RAF is .0015% of a company's revenues or \$50, whichever is greater.

Once the Commission receives your payment or the date the 2001 RAF will be paid, a docket will be established to cancel your certificate voluntarily.
