

PERDIDO BAY CENTRAL OFFICE**


BellSouth Telecommunications, Inc. ("BellSouth"), hereby withdraws its  
Petition for Temporary Waiver of Physical Collocation Requirements in the Perdido  
Bay Central Office and states the following:

1. On June 27, 2000, BellSouth filed a Notice of Intent to Request  
Temporary Waiver of Physical Collocation Requirements in the Perdido Bay central  
office. On July 10, 2000 BellSouth and the Florida Public Service Commission  
Staff conducted a tour of this central office. On July 17, 2000, BellSouth filed its  
Petition for Temporary Waiver and filed its Post-Tour Report on July 25, 2000. On  
September 18, 2000, the Florida Public Service Commission ("Commission") issued  
Order No. PSC-00-1222-FOF-TL, granting BellSouth a Temporary Waiver of  
Physical Collocation Requirements in the Perdido Bay central office until December  
31, 2002.

3. BellSouth hereby withdraws the above-referenced Petition for Extension of the Temporary Waiver as all ALECs on the waiting list have either been served or no longer desire space in the Perdido Bay central office.
