This is in response to Order No. PSC-01-2193-PAA-TI issued August 16, 2001 in Docket No. 011039-TI.

We have had this telecommunications certificate since 1999 and apologize that the Florida Public Service Commission had to establish a docket to collect the regulatory assessment fee.
