I was checking the above referenced agreement for an approval order and could not find one. Upon reviewing the docket information that I have in my file, I believe the docket was closed and the agreement was never acted on.

The IURC agreement was filed on January 18, 2001 and issued Docket 010070-TP. On January 19, 2001 we filed an amendment in that docket.
