

Jessica, this is the docket where we mistakenly indicated in the docket title that cancellation was to be effective 9/26/01 (rather than 9/26/00). You were going to check with Paula Isler on 7/17 about the effective date, and you said "but unless there is a reason why the company would have an effective cancellation date of 12/31/00 they will be responsible for the 2001 RAFs anyway and if the effective cancellation date should have been May 7, 2001, then the practical effect is the same as the 9/26/01 date the Commission voted on and we do not have to take this back to Agenda." I have not heard back from you. The consummating order has now been issued.

It is OK to stick with the 2001 date. As a matter of fact, we do not normally grant retroactive dates as the cancellation date unless the company can prove that it had requested cancellation for the retro date, such as providing us with a copy of correspondence to the Commission with the retro date. In other words, this company would have needed to provide a letter dated 9/26/00 showing that it had requested cancellation. Normally, the effective date of a cancellation is the date the Commission received the company's request.

Paula, please see e-mails below. Jessica and I have been discussing this, but I thought I would run this by you as well, though it is not actually a CMP matter.

We opened this docket and mistakenly indicated the cert cancellation would be effective 9/26/01—company had indicated it was effective 9/26/00. The company did not specifically request we cancel the docket effective 9/26/00, however. The order, PAA and CO, both kept effective date of 9/26/01. This means company will owe 2001 RAFs.

Since company did not specifically request 9/26/00 effective date, are we okay to stick with a 2001 effective date, meaning company will owe this year's RAFs?
