Dear Mr. Vlandis:

This is a follow up to our telephone conversation on December 14, 2001, concerning the company's request for cancellation of its pay telephone certificate. Rule 25-24.514(2)(a) and (b), Florida Administrative Code, provides that when requesting cancellation of its certificate, a company must either pay the current year's RAF or provide a date certain it would be paid.

On October 5, 2001, the Commission received Ms. Vlandis' letter dated October 1, requesting cancellation, advising the company had been sold to COAST-tel Payphones, and stating that any outstanding regulatory assessment fees (RAF) would be paid in January 2002. I took Ms. Vlandis' statement to mean that the 2001 RAF would be paid in January 2002, which meant that she had complied with the rule. However, before we can recommend a voluntary cancellation, a company must also pay any past due charges.

I wrote Ms. Vlandis on October 12<sup>th</sup> and explained that the company owed \$14.75 in past due penalty and interest charges for late payments of the 1998, 1999, and 2000 RAFs, which needed to be paid before we could go forward with the voluntary cancellation.

Then in December, you called and asked for the exact amount of the past due balance, which was \$14.75. I did not add in the \$50.00 minimum amount due for the 2001 year because it did not become past due until after January 30, 2002. On January 31, 2002, the Commission received your payment for \$15.00, but as of this date, the 2001 RAF remains unpaid.

The 2001 RAF return form is attached. Please complete it and return it with payment for the 2001 RAF, along with applicable penalty and interest charges, or a total of \$53.00. As soon as payment for the 2001 RAF is received, a docket will be established to voluntarily cancel TelePro Services' payphone certificate.

Dear Ms. Vlandis:

On October 5, 2001, the Commission received your October 1<sup>st</sup> letter requesting cancellation of the company's certificate. There are two kinds of cancellations. The first is voluntary, which is normally granted if the company is in good standing with the Commission and does not have a past due balance of the Regulatory Assessment Fee (RAF). The other is involuntary. If a company is <u>not</u> in good standing and has an outstanding balance, the Commission normally cancels the certificate on its own motion for a rule violation.

As information, the RAF is assessed if a certificate is active for any one day during a calendar year. The RAF is due by January 30 of each year, unless the 30th falls on a weekend, then the fee is due by the next working day, for the previous year. If payment for the RAF is mailed after the due date, then statutory penalty and interest charges are applicable.

According to Commission records, your company has an outstanding penalty and interest balance in the amount of \$14.75 for late payment of the RAF for the years 1998, 1999, and 2000. A breakdown of the charges is attached. Therefore, I cannot recommend a voluntary cancellation of your certificate until the past due balance is paid.
