**BARTOW'S MOTION FOR CONTINUANCE**

Petitioner, City of Bartow, Florida, by and through its undersigned attorneys, moves the Florida Public Service Commission to continue and readjust the schedule of proceedings herein, and in support states as follows:

1. On Tuesday, April 16, 2002, the City of Bartow ("Bartow"), Tampa Electric Company ("TECO"), and the Florida Public Service Commission ("PSC") staff met to discuss the pending action.

2. At that meeting, the PSC staff indicated that the final configuration of the Old Florida Plantation ("OFP") development, including the location of the primary spine road in the development, as well as the areas where commercial property and housing developments would be finally located, were essential to determination of the issues in the case.


3. Bartow has spoken to the managing partner of the OFP development and has learned that there is currently pending a jury trial scheduled to begin on August 5, 2002, between OFP and the gas pipe line company that has located its pipe line on property within the OFP development.

4. Because of the location of this gas pipe line, OFP is in the process of relocating the principal spine road of the development, as well as relocating commercial and residential areas within the development.

5. OFP has indicated that this redesign of the development should be completed either immediately before or shortly after the trial of the case.

6. In view of the fact that the information needed by the PSC to evaluate the merits of this case will not be available until August, Bartow requests that the PSC not schedule a final hearing in this matter until after August, when the relevant information relating to the OFP development becomes finalized.

WHEREFORE, the City of Bartow, Florida, requests that the proceedings and final hearing date of July 18, 2002, be continued to a date after August 2002.
