**RE:** Request for Permission from Comptroller's Office to Write-Off the RAFs for the years

1999, 2000, 2001, and 2002 for Crescent Public Communications, Inc. (TF916).

By Order No. PSC-02-0842-PAA-TC, issued on June 19, 2002, the Commission approved the cancellation of TF916's Pay Telephone Certificate No. 5012 due to bankruptcy. The Commission further ordered that the outstanding Regulatory Assessment Fees not be sent to the Comptroller's Office for collection, but instead, that the Division of the Commission Clerk and Administrative Services should request permission to write-off the uncollectible amount.

Therefore, staff requests that Bureau of Administrative Services/Fiscal Services Section take the appropriate steps to seek permission from the Comptroller's Office to write-off the uncollectible RAFs for the years 1999, 2000, 2001, and 2002, and statutory penalties and interest charges for the years 1998, 1999, 2000, and 2001 for TF916.
