Returned to you are documents 02347-98, 02348-98, and 02349-98. These documents should be held as confidential pursuant to a claim of confidentiality made by BellSouth on June 26, 1998 (See PSC document 06866-98 – copy attached).

BellSouth's June 26, 1998, letter indicates through notes placed in the margin that a confidential claim is sought for Commission documents 02347-98, 02348-98, 02349-98 and 03025-98.

Our research into this matter indicates:

- A) On November 24, 1998, Order PSC-98-1574-CFO-TP granted a confidential classification to Document 03025-98;
- B) On August 30, 2000, Commission Order PSC-00-1565-CFO-TP extended this confidential classification for document 03025-98 until February 28, 2002;
- C) On February 28, 2002, documents 02347-98, 02348-98, 02349-98 were declassified and returned to the Division of Auditing and Safety;
- D) On April 29, 2002, BellSouth requested a second extension of the confidential classification for document 03025-98 this request is currently pending.

A hearing has been held, the staff auditor in the case has testified, and none of the audit material presented at the hearing is currently classified as confidential. We therefore recommend that BellSouth's June 26, 1998 claim of confidentiality be recognized for documents 02347-98, 02348-98, 02349-98 and 03025-98.

Any protection granted by the claim should last for 5 years or until this docket is closed whichever is longer. At that time the staff woking papers (documents 02347-98, 02348-98 and 02349-98) may be destroyed and document 03025-98 may be returned to BellSouth. Staff attorney Beth Keating has contacted BellSouth and asked the utility to withdraw its pending request since the material is currently protected.
