We apologize for the oversight in filing this document. 01 has experienced several internal and personnel changes in this past year and the failure to forward the form and payment is simply an oversight. We did forward a payment earlier this year for another certificate and simply overlooked this submission and made a mistake. We have enlisted outside support and implemented procedures to ensure that we provide timely responses and filings in the future and do not anticipate a recurrence of this event.
