Enclosed is a check in the amount of \$66.90 and the applicable competed 2001 Regulatory Assessment Fee document on behalf of 01 Communications of Florida, LLC ("01"). 01 definitely wishes to keep its Certificate active and in compliance with Commission rules. We apologize for the oversight in filing this document. 01 has experienced several internal and personnel changes in this past year and the failure to forward the form and payment is simply an oversight. We did forward a payment earlier this year for another certificate and simply overlooked this submission and made a mistake. We have enlisted outside support and implemented procedures to ensure that we provide timely responses and filings in the future and do not anticipate a recurrence of this event.

We understand that there may be a question of a fine for failing to file the RAF in addition to the penalty and interest added to the RAF amount. 01 Communications of Florida, LLC respectfully proposes to pay \$100 as monetary settlement for the violation, which will be paid within 14 calendar days after the Commission Order is issued. Further, the Company agrees to waive any objection to the administrative cancellation of its certificate should 01 fail to pay in accordance with its settlement offer. If, however, there is a factual dispute as to the manner or level of compliance with any provision in the settlement, Commission Staff will bring the matter to the Commission for consideration.
