3. In this docket, the Commission will address the requirements of the Federal Communications Commission's (FCC) *Triennial Review Order*.

4. AT&T is a telecommunications company that has been duly certificated by the Commission as a competitive local exchange telecommunications company ("CLEC") and an interexchange company ("IXC") in Florida. As such, AT&T is subject to the rules, regulations and orders of the Commission, and such rules, regulations and orders impact AT&T's ability to provide local exchange telecommunications service and intrastate interexchange telecommunications service.

5. As a CLEC, AT&T purchases unbundled network elements ("UNEs") from incumbent local exchange companies ("ILECs") and exchanges traffic with ILECs and other CLECs in order to provide local exchange service. Accordingly, AT&T's substantial interests may or will be affected by any action that the Commission takes in this docket regarding the application of the *Triennial Review Order*.

WHEREFORE, AT&T requests that it be permitted to intervene in this proceeding and that it be accorded full party status.


