ORDER ESTABLISHING 2004 DOCKET NUMBER

BY THE COMMISSION:

In order to avoid confusion and reduce administrative handling problems in this active and continuing docket, we are establishing a new docket for the calendar year 2004. Beginning January 2, 2004, Docket No. 030005-WS, Annual Reestablishment of Price Increase or Decrease Index of Major Categories of Operating Costs Incurred by Water and Wastewater Utilities Pursuant to Section 367.081(4)(a), Florida Statutes, will be identified as Docket No. 040005-WS.

The establishment of a new docket number is for administrative convenience only and this Commission retains its continuing jurisdiction over matters considered in previous annual reestablishment of price increase or decrease index dockets. The new docket number will be used by all parties on the effective date of January 2, 2004, and thereafter.

Based on the foregoing, it is therefore

ORDERED by the Florida Public Service Commission that beginning January 2, 2004, all matters previously the subject of Docket No. 030005-WS, shall be part of Docket No. 040005-WS. It is further

ORDERED that this Commission shall retain jurisdiction over matters considered in previous annual reestablishment of price increase or decrease index dockets.

NOTICE OF FURTHER PROCEEDINGS OR JUDICIAL REVIEW

The Florida Public Service Commission is required by Section 120.569(1), Florida Statutes, to notify parties of any administrative hearing or judicial review of Commission orders that is available under Sections 120.57 or 120.68, Florida Statutes, as well as the procedures and time limits that apply. This notice should not be construed to mean all requests for an administrative hearing or judicial review will be granted or result in the relief sought.

Mediation may be available on a case-by-case basis. If mediation is conducted, it does not affect a substantially interested person's right to a hearing.

Any party adversely affected by this order, which is preliminary, procedural or intermediate in nature, may request: (1) reconsideration within 10 days pursuant to Rule 25-22.0376, Florida Administrative Code, if issued by a Prehearing Officer; (2) reconsideration within 15 days pursuant to Rule 25-22.060, Florida Administrative Code, if issued by the Commission; or (3) judicial review by the Florida Supreme Court, in the case of an electric, gas or telephone utility, or the First District Court of Appeal, in the case of a water or wastewater utility. A motion for reconsideration shall be filed with the Director, Division of the Commission Clerk and Administrative Services, in the form prescribed by Rule 25-22.060, Florida Administrative Code. Judicial review of a preliminary, procedural or intermediate ruling or order is available if review of the final action will not provide an adequate remedy. Such review may be requested from the appropriate court, as described above, pursuant to Rule 9.100, Florida Rules of Appellate Procedure.
