It was Mr. Friedman, ATTORNEY for IEU who stated in his MARCH 20, 2003 letter to the PSC that "since IEU is not yet in operation ... it does not have any financial statements" and that "the financial ability of IEU, Inc ... is based upon the financial ability of its share holders..." These share holders are DEAN BECKSTEAD, GARFIELD BECKSTEAD, and John Boyer. ALL FUNDING is to be based upon the financial abilities of these same share holders.
5. there has been no change in the relevant facts from the original Objections to Discovery filed by IEU Oct 3, 2003 that would be germane to the present Motion for Reconsideration, so there is nothing new to reconsider.
6. It appears that the sole reason given to request the ~~reconsideration~~ reconsideration is the misplaced, untrue and improper personal attack against me, that has no role in these proceedings.
7. IEU had requested and received personal financial information from Mr. Koenig.
8. Mr. FRIEDMAN AT THE JULY 16, 2003 CONFERENCE CALL WITH THE PSC AND INTERVENERS STATED THE FINANCIAL RECORDS WOULD BE AVAILABLE AND BE PROVIDED BY AUG 15, 2003

9. The shareholders have not requested that their personal financial statements be classified as specified confidential material and it is presumptuous of Mr. Friedman to assume that that determination would be meaningless if granted.
10. In a letter dated Feb 20, 2003 the commission also requested that the applicant (shareholder) demonstrate its financial ability.
11. This request is reasonably calculated to lead to the discovery of admissible evidence.
12. It has not been shown that the disclosing of the financial information would hurt the applicant.
13. Based on the above I request that the commission deny the Motion for ~~Record~~ Reconsideration.
