Majoros, Jr., a witness on behalf of the Florida Industrial Power Users Group and Office of Public Counsel, and says:


1. Mr. Majoros's deposition was taken on Friday, April 9, 2004. Subsequent to that date Tampa Electric reviewed the transcript of Mr. Majoros's deposition and highlighted in yellow the information Tampa Electric considers to be proprietary confidential business information. Pursuant to Staff's request a single copy of Mr. Majoros's deposition transcript was filed as a confidential document with the Commission Clerk's Office on May 4, 2004 and identified as Document No. 05119-04.

2. The information highlighted in yellow in Mr. Majoros's deposition is confidential proprietary business information the disclosure of which would be harmful to Tampa Electric, its affiliate transportation provider, other bidders, and ultimately Tampa Electric's customers.

3. Tampa Electric will follow this Notice of Intent with a formal request and justification for confidential treatment within the time allowed under Rule 25-22.006, Florida Administrative Code.


