NOTICE is hereby given that the Florida Public Service Commission will hold a hearing in the above docket at the time and place listed below.

Wednesday, June 2, 2004, 9:30 a.m. Betty Easley Conference Center, Room 148 4075 Esplanade Way Tallahassee. Florida

June 3, 2004, has also been reserved for continuation of the hearing, if necessary. All persons who wish to be heard are urged to be present at the beginning of the hearing on June 2, 2004. The starting time of the second day's session sill be announced at the conclusion of the first day's session. The hearing may be adjourned early if all testimony is concluded.

PURPOSE AND PROCEDURE

The purpose of this hearing will be for the Commission to take final action to determine the need, pursuant to Section 403.519, Florida Statutes, for the electrical power plant and related facilities proposed by Florida Power & Light Company (FPL) for construction in Dade County, Florida. This proceeding shall allow FPL to present evidence and testimony in support of its petition for a determination of need for the proposed plant and related facilities; to permit any intervenors to present testimony and exhibits concerning this matter, to permit members of the public who are not parties to the need determination proceeding the opportunity to present testimony concerning this matter, and for such other purposes as the Commission may deem appropriate. All witnesses shall be subject to cross-examination at the conclusion of their testimony.

The proceedings will be governed by the provisions of Chapter 120, Florida Statutes, Section 403.519, Florida Statutes, and Chapters 25-22 and 28-106, Florida Administrative Code.

Under Section 403.519, the Commission is the sole forum for the determination of need for the electrical power plant and associated facilities. In making its determination, the Commission must take into account the need for electric system reliability and integrity, the need for adequate electricity at a reasonable cost, and whether the proposed plant is the most cost-effective alternative available. In addition, the Commission must expressly consider the conservation measures taken by or reasonably available to the applicants which might mitigate the need for the proposed plant and may consider other matters within its jurisdiction which it deems relevant. The Commission's determination of need for the Dade County facility shall create a presumption of public need and necessity and shall serve as the Commission's report required by Subsection 403.507(2)(a)(2), Florida Statutes. An order entered by the Commission pursuant to this hearing shall constitute final agency action.

Only issues relating to the need for the power plant and related facilities will be heard at the June 2-3, 2004, hearing. Separate public hearings will be held before the Division of Administrative Hearings at a later date to consider environmental and other impacts of the proposed plant and associated facilities.

Members of the public who are not parties to the need determination proceeding will have an opportunity to present testimony regarding the need for the proposed plant and associated facilities. All members of the public who wish to offer testimony should be present at the beginning of the hearing, 9:30 a.m., Wednesday, June 2, 2004. All witnesses will be sworn in and will be subject to cross-examination at the conclusion of their testimony.

Anyone wishing to become a party to the need determination proceeding should file an appropriate petition pursuant to Rule 25-22.039, Florida Administrative Code, with the Director of the Commission's Division of the Commission Clerk and Administrative Services at the address listed above. Copies of the petition should be sent by mail to all parties. Those wishing to intervene in these proceedings, unless appearing on their own behalf, must be represented by an attorney or other person who can be determined to be a qualified representative pursuant to Chapter 120, Florida Statutes, and Rule 28-106.106, Florida Administrative Code. Petitions for leave to intervene must be filed at least five (5) days before the final hearing, must conform with Rule 28-106.201/20, Florida Administrative Code, and must include allegations sufficient to demonstrate that the intervenor is entitled to participate in the proceeding as a matter of constitutional or statutory right or pursuant to Commission rule, or that the substantial interests of the intervenor are subject to determination or will be affected through the hearing.

GENERAL LOCATION AND PROJECT DESCRIPTION

The proposed electrical power plant is estimated to produce a summer net capacity of approximately 1,144 MW, and an approximate winter rating of 1,181 MW. The proposed plant is to be located adjacent to FPL's current Turkey Point complex, approximately 8 miles east of Florida City and 4.5 miles east of of the eastern boundary of the city of Homestead, in Dade County, Florida. The proposed unit consists of a new natural-gas fired, four-on-one combined cycle facility, designed to utilize four combustion turbines, four heat recovery steam generators, and one steam turbine generator, and other related facilities. The proposed plant is estimated to commence commercial operation by June 2007.
