BellSouth Telecommunications, Inc. ("BellSouth"), pursuant to Rule 28-106.204(5), Florida Administrative Code, requests that the Florida Public Service Commission ("Commission") grant BellSouth a seven (7) day extension of time or until July 13, 2003, in which to respond to discovery propounded by Supra Telecommunications & Information Systems, Inc ("Supra"). In support of this motion, BellSouth states the following:

- Supra propounded its Second Set of Interrogatories and Requests for Production to BellSouth at 4:59 p.m. on July 25, 2004.
- 2. Pursuant to Pursuant Order No. PSC-04-0459-PCO-TP ("Procedural Order"), objections to discovery are due within five business days of service of the discovery and responses are due within 10 calendar days of service of the discovery.
- 3. On July 2, 2004, BellSouth timely filed its objections to Supra's discovery.
- 4. Pursuant to the Procedural Order, BellSouth's responses to the discovery are due on July 6, 2004.

- 5. Because of the recent holiday and the undersigned's travel schedule, BellSouth needs an additional seven (7) days time to respond to Supra's discovery.
- because no hearing date or testimony deadline date has been established in this docket.
