SEBRING GAS SYSTEM, INC. NOTICE OF CUSTOMER MEETINGS DOCKET NO. 040270-GU

On Jone 30, 2004. Sebring Gas System, Inc. filed a petition for general rate increase with the Florida Public Service Commission ("PSC") for an excrease in natural gas rates. In this rate case, the Company is seeking approval of new permanent rates that would generate additional base rate revenues of \$234,641 a year. The Company has also requested that the Commission approve interim rates that would generate additional revenues of \$110,957, on an annualized basis, during the time that this rate case is being processed by the PSC.

The PSC will hold a customer meeting in Sebring to receive comments from customers on the Company's quality of service and on other matters perfaining to the Company's request for rate relief. One or more Commissioners of the Florida' Public Service Commission may be present at the customer meeting. The customer meeting will be held at the following location and time:
