**Joint Motion of Florida Power & Light Company

Pursuant to Rules 28-106.204 and 28-106.303, Florida Administrative Code, co-applicants Florida Power & Light Company (“FPL”) and New Hope Power Partnership (“New Hope”) move that the Prehearing Conference scheduled in these proceedings for October 7, 2004 be rescheduled for the afternoon of October 4, 2004. In support of this joint motion, FPL and New Hope state:


1. In the Order Establishing Procedure in these proceedings, Order No. PSC-04-0754-PCO-EI, the Prehearing Conference was scheduled for October 7, 2004.

2. FPL’s counsel has a scheduling conflict that would preclude him from attending either the scheduled Prehearing Conference or another scheduled activity on October 7, 2004. To avoid this scheduling conflict, counsel for FPL has contacted counsel for all parties of record and inquired if rescheduling the Prehearing Conference from October 7, 2004 to the afternoon of October 4, 2004 would inconvenience any of the parties or their counsel or otherwise prejudice the parties. No prejudice would be occasioned by the rescheduling, and none of the counsel raised any objection. (Rescheduling to the afternoon is respectfully requested because New


Hope's counsel has a scheduling conflict during the morning of October 4, 2004.) Indeed, counsel for all parties of record have agreed to the proposed rescheduling of the Prehearing Conference from October 7, 2004 to the afternoon of October 4, 2004.


