September Status Report Regarding Zellwood Station Cooperative

Transfer to Orange County

Dear Ms. Merchant:

Pursuant to our prior commitment, I am providing to you and all other parties to this proceeding our status report of activities concerning the transfer of the water and sewer plants from Zellwood Station Cooperative to Orange County for the month of September.

Zellwood and Orange County met on September 30, 2004, for discussions on how best to resolve the final deal issue related to certain releases the County wanted from Zellwood as part of the closing conditions for the sale of the Zellwood system. In this meeting, the County announced a new proposal to deal with this issue whereby the County will only acquire the retail customers of Zellwood without the water and wastewater treatment facilities themselves. The existing Zellwood water and wastewater treatment facilities will be abandoned upon the transfer of the retail customers to the County. The County will then provide the required wholesale water and wastewater service to Zellwood retail users through an agreement for such capacity with the City of Apopka. This approach removes the need for the releases that were being requested by the County from Zellwood. This approach will require the consent of the City of Apopka and the City of Apopka is expected to give its consent within the next 30 days. The County is expected to submit the revised deal to the Board of County Commissioners on October 26, 2004, for final approval. From Zellwood's perspective, the new deal will change nothing except the ultimate source of the water and wastewater capacity provided by the County, which will be facilities operated by the City of Apopka.
