HUDSON UTILITIES INC.'S PETITION FOR APPROVAL OF APPLICATION FOR AMENDMENT OF CERTIFICATE NUMBER 104-S

COMES NOW Hudson Utilities, Inc. ("Hudson"), by and through its undersigned counsel, and pursuant to Section 367.045(2), Florida Statutes and Rules 25-30.030, 25-30.032 and 25-30.036, Florida Administrative Code, hereby requests the Florida Public Service Commission ("Commission") to amend Certificate No. 104-S to delete certain portions of Hudson's service territory in Pasco County within a residential subdivision named Sea Pines. In support of this Petition and Application, Hudson states as follows:

2. Hudson's complete name and address are as follows:

3. Hudson is a Class B Wastewater Utility providing service to the public in Pasco



County, Florida pursuant to Certificate No. 104-S.¹ Hudson provides wastewater collection service to its customers, and contracts with Pasco County for wastewater treatment service pursuant to a bulk wastewater treatment agreement interred into on June 5, 1990.²

- 4. On September 27, 1999, the Commission issued an order amending Hudson's Certificate to include additional service territory, including, among other areas, the Sea Pines subdivision.³
- 5. The legal descriptions of the Sea Pines area that is currently within Hudson's existing service territory and which Hudson seeks to delete is provided as Exhibit "A" to Hudson's application. A service area location map depicting Hudson's existing and proposed service areas is provided as Exhibit "B" to the application.
- 6. The majority of Hudson's existing service territory is located in an area federally designated as a flood plain area, which is unsuitable for the efficient use of septic tanks and drain fields. The comprehensive land use plan adopted by Pasco County and the State of Florida requires that coastal areas, including Hudson's existing and proposed service territory, shall be provided with sanitary sewer collection and treatment systems. Pasco County owns and operates regional wastewater treatment and disposal facilities, and currently provides wastewater service

to some residents of the Sea Pines subdivision, outside of Hudson's current service territory. The proposed deletion of Hudson's service territory is consistent with the comprehensive plan adopted by Pasco County.

- 7. The number of current active connections within the territory that Hudson seeks to delete is 213.
- 8. Hudson seeks to delete its Sea Pines territory because extension of service to potential customers within Sea Pines could be accomplished only at an unreasonable cost to Hudson.⁴
- 9. Hudson's rates and charges were established in the Commission's Order No. 23810 issued November 27, 1990 in Docket No. 900293-SU in response to Hudson's application for staff assisted rate case, and were amended most recently by Order No. PSC-02-1626-PAA-SU issued November 25, 2002. The proposed deletion of Hudson's service territory is not expected to impact Hudson's monthly rates and service availability charges.
- 10. The proposed deletion of territory is in the public interest as the customers are located in an area federally designated as a flood plain area which is unsuitable for the efficient use of septic tanks and drain fields, which is how most Sea Pines residents in Hudson's service territory currently receive wastewater service. By deleting the territory, Hudson affords an opportunity for Pasco County or any other potential wastewater provider to provide wastewater service with sanitary sewer collection and treatment systems to all residents of Sea Pines.
 - 11. Pursuant to Rule 25-30.020, Hudson hereby files an application fee in the amount

of \$500.00.

- Pursuant to Section 367.045(2), Florida Statues, and Rule 25-30.036, F.A.C., 12. Hudson hereby attaches the following: (i) the original and two copies of sample tariff sheets reflecting the revised service area are attached hereto as Exhibit "C"; (ii) Hudson's current certificate for possible amendment to its territory is attached hereto as Exhibit "D"; (iii) an affidavit that Hudson has tariffs and annual reports on file with the Commission is attached hereto as Exhibit "E"; and (iv) an affidavit swearing or affirming that the facts stated in the application and all exhibits attached thereto are true and correct and that said statements of fact thereto constitute a complete statement of the matter to which they relate is attached hereto as Exhibit "F."
- 13. Pursuant to Rule 25-30.030, F.A.C., the Affidavits addressing Hudson's compliance with notice requirements will be filed as late-filed exhibits.






