COMES NOW, BellSouth Telecommunications, Inc. ("BellSouth"), pursuant to Rule 25-22.006, Florida Administrative Code, and Section 364.183, Florida Statutes, and files this Request for Specified Confidential Classification and states the following:

1. On October 12, 2004, the Commission Staff held an informal conference to discuss the remaining issues (if any) with the 50/50 plan established in the docket for allocating resources for certain change management requests and the Final Report prepared by Price Waterhouse Coopers ("PwC") regarding such plan. During the informal conference BellSouth agreed to provide for the Staff's review only, certain proprietary documents associated with the 50/50 plan. Specifically, BellSouth agreed to provide Appendix I Methods and Procedures to the Change Control Process, a CCP & Maintenance Classification and other CCP Terminology Training Presentation, and a Project Charter Template which addresses Attachment C, Item 7. Additionally, BellSouth agreed to make available for review and inspection to the Commission Staff only, the Harvest System Administrator's Guide at the offices of Nancy Sims, 150 S.
