Dear Sirs:

On October 21, 2004, the Department received information concerning an application to delete wastewater territory in Pasco County, by Hudson Utilities, Inc. Pursuant to the Memorandum of Understanding between the Public Service Commission (PSC) and the Department of Community Affairs, the Department has agreed to review applications for new or revised service and provide comment on the need for service and comprehensive plan consistency. The Department has completed its review and offers the following comments:

Based on our review, the proposed deletion by Hudson Utilities, Inc., appears to be consistent with the Pasco County comprehensive plan. As we understand, Hudson Utilities, Inc. currently has wastewater service territory in portions of the Sea Pines subdivision; however, this area is not currently being served by Hudson Utilities, Inc. We understand that the remainder of the Sea Pines subdivision is currently being served by Pasco County and the County is currently negotiating to serve those areas that will be deleted from Hudson Utilities service area. The CMP proposed service deletion area is currently designated as Residential-6 land use, which allows up COM to six dwelling units per acre. Pasco County Public Facilities Element – Potable Water Policies 1.1.6 and 2.1.3 require the provision of public water service to lands designated on the Future CTR land Use Map as RES-3 (Residential – 3 dwelling units/acre) or higher. The Department does ECR -not object to the proposed deletion of wastewater service to the affected service area.
