**XO FLORIDA, INC.'S RESPONSE TO
BELLSOUTH TELECOMMUNICATIONS, INC.'S
REQUEST FOR CLARIFICATION OF DISCOVERY REQUEST**

XO Florida, Inc. (XO), provides this clarification to BellSouth Telecommunications, Inc.'s (BellSouth) Request for Clarification of XO Interrogatory No. 5.

1. XO Interrogatory No. 5 states:

Provide and explain in detail Bell's proposed price for a "switch as is," or conversion without disconnection and reconnection of the circuit, for conversion of special access zero mileage loops to UNE loops, including an explanation of each charge and the basis for each charge.

2. BellSouth claims this interrogatory is "vague and ambiguous" because XO does not define what it means by "Bell's proposed price for a 'switch as is'".

3. XO's question is neither vague nor ambiguous. In fact, it is quite simple. XO is simply asking BellSouth to definitively state its proposed total price for the conversion of zero mile special access loops to UNE loops, without physical change to or disconnection of the loop. BellSouth currently has a "switch as is" rate for conversion of mileage special access loops to UNE EELs. XO simply seeks to discover what BellSouth's comparable proposed price for "switch as is" of zero mile special access loops to UNE loops is. The question also requests explanation of the charge, including

any and all components of the charge, or, in simplest terms, "what such charge(s) are for."
