Dear Mr. Crouch:

Two years ago, Governor Bush signed the Service First Initiative into law. Your position at that time and those of many other state employees were reclassified under Service First from Career Service to Select Exempt Service to reflect managerial, supervisory and/or confidential responsibilities. Recently, the Florida First District Court of Appeal determined that those state employees whose positions were reclassified may be entitled to an administrative hearing to determine whether the reclassified position met the statutory criteria for Career Service exemption under section 110.205(2), Florida Statutes (2001).

Therefore, if you believe the reclassification of your position was not justified, you may petition the agency for review in accordance with Rule 28-106, Florida Administrative Code (F.A.C.). If you decide to do so, your petition must be received by the agency within 21 days of your receipt of this letter and must be sent to the following address:

Upon receipt of the petition, you will be notified of all further proceedings that may be conducted. If you do not file a petition within 21 days, you will waive any right to request a hearing in this matter in accordance with Rule 28-106.111, F.A.C. Mediation is not available to resolve this matter. Please be advised that if the Public Employee Relations Commission has already ruled on the propriety of your reclassification, you may not be entitled to any additional administrative relief.
