BellSouth Telecommunications, Inc. ("BellSouth"), pursuant to Rule 25-22.006, Florida Administrative Code, and Section 364.183, Florida Statutes, files this Request for Specified Confidential Classification.

1. On January 31, 2005, BellSouth Telecommunications, Inc. ("BellSouth"), pursuant to Commission Order No. PSC-05-0096-PCO-TP, filed its Supplemental Responses to XO Florida Inc. ("XO")'s First Set of Interrogatories (Nos. 3 and 8) and First Request for Production of Documents (No. 2), dated November 22, 2004.

2. In order for Staff to take possession of BellSouth's responses to XO, on January 31, 2005, BellSouth filed a Notice of Intent, in particular, the documents provided in BellSouth's Supplemental Response to XO's First Request for Production, Item No. 2, which contains confidential business, proprietary information. 5. The information discussed in this Request for Specified Confidential Classification is valuable, BellSouth treats this business information as confidential in all requests, and this information has not been generally disclosed.


6. The original of this Request was filed today with the Division of the Commission Clerk and Administrative Services and a copy was served on the Parties.

**Explanation of Proprietary Information**

1. This material is proprietary and confidential business information of a technical nature used by BellSouth in conducting its business and not commonly known by or available to the public.
