We are in receipt of a notice issued October 18, 2005, pursuant to Section 367.045, Florida Statues, of the application of MSM Utilities, LLC to amend its Water Certificate No. 611-W and Wastewater Certificate No. 527-S to add territory in Charlotte County Florida as described in Exhibit A (attached).

We wish to raise our objection to this increase of their territories covered by the proposal. The reasons are as follows:

- 1. The project will conflict with the City of Punta Gorda and Charlotte County's utility development plan.
- 2. As the county utilities grow around us, the county will be forced to purchase the franchise from MSM Utilities specifically if they cannot maintain regulatory compliance of their systems or the physical and the economic demand for the water/wastewater rights. MSM will inevitably sell their franchise to the county at a large profit at the county's and the community's expense.
- 3. Although MSM Utilities maintain that they will be able to utilize the railroads or county easement to run their water lines, they actually will try to seize varies property rights for those lines through eminent domain. Giving MSM access to eminent domain to seize properties to expand their utilities would cause undo hardship on those impacted residence. COM 4. The compliance history of MSM with the regulatory agencies comes into question. What is their track record with both the EPA and Florida statues. The City of Punta Gorda and the County have a utility plan that will meet our needs and protect the environment when it is time to hook up or be part of the water system from Punta Gorda. To give this private company a utility expansion permit would only add cost to this utility plan and OPC ____hinder the implementation of that plan. We are formally requesting that we be copied on all correspondence and e-mails as it relates _to this project so that we would adequately be able to file a timely request of an administrative hearing. 
