Dear Ms. Callender:

This is a follow up to our telephone conversation concerning your recent letter requesting cancellation of Speedy Reconnect, Inc.'s CLEC certificate. Before I can open a docket and recommend a voluntary cancellation, the company must pay any outstanding fees, including statutory late payment charges, plus the current year's fee. The 2006 Regulatory Assessment Fee return form, Line 14, states "Total amount due (\$50 minimum)." In addition, our records show Speedy Reconnect, Inc. has a past due balance of \$12 for late payment of the 2003, 2004, and 2005 fees. I am attaching the breakdown for each of the three years.

As soon as payment in the amount of \$62 is received, I will establish a docket to cancel Speedy Reconnect, Inc.'s CLEC certificate. Please note that payment must be received by the due date of January 30th to avoid being responsible for the 2007 fee (which, by the way, is increasing to a minimum of \$600).
