SouthernNet Systems, Inc. has requested cancellation of its IXC tariff and Registration No. TI907, effective November 22, 2006. The company has complied with the provision of Rule 25-24.474(2), Florida Administrative Code, by providing adequate notice in writing of its request for cancellation. In addition, SouthernNet Systems, Inc. paid the 2006 Regulatory Assessment Fee, as required in Section 364.336, Florida Statutes. If SouthernNet Systems, Inc. commences operations in Florida as an intrastate interexchange carrier in the future, a new registration must be filed.

As required by Section 2.07.C.5.i., Administrative Procedures Manual, SouthernNet Systems, Inc., holder of IXC Registration No. TI907, has paid the required Regulatory Assessment Fees and can be removed from the IXC Registration list effective November 22, 2006.

In addition, Southernnet Inc. d/b/a Telecom\*USA, Inc. has requested cancellation of Pay Telephone Certificate No. 2455, effective November 22, 2006. The certificate holder has complied with the provision of Rule 25-24.514(2), Florida Administrative Code, by providing adequate notice in writing of its request for cancellation of its certificate. In addition, Southernnet Inc. d/b/a Telecom\*USA, Inc. paid the 2006 Regulatory Assessment Fee.

Pursuant to Section 2.07.C.5.c., Administrative Procedures Manual, it is our recommendation that the voluntary cancellation be approved and an administrative order be issued.
