# APPLICATION BY ST. JAMES ISLAND UTILITY COMPANY FOR "QUICK TAKE" AMENDMENT TO CERTIFICATES OF AUTHORIZATION TO EXTEND WATER AND WATER SERVICE IN FRANKLIN COUNTY, FLORIDA

St. James Island Utility Company ("St. James") or ("Utility"), by and through its undersigned counsel, and pursuant to Section 367.045(2), Florida Statutes, and Rule 25-30.036, Florida Administrative Code, hereby files this Application for Amendment to Certificate Numbers 621-W and 534-S to extend its water and wastewater service to include certain territory in Franklin County as described herein. In support of this Application, St. James states as follows:

1. The name and address of the applicant utility is:

St. James Island Utility Company 3800 Esplanade Way Ste. 100 Tallahassee, Florida 32311

2. The names and address of the utility's authorized representatives are:

3. St. James is wholly owned by the St. Joe Company ("St. Joe" or "Developer") and provides water and wastewater service to SummerCamp, a planned community located along

Highway 98 between Carabelle and Alligator Point which is being developed by St. Joe.

- 4. By Order No. PSC-04-0755-PAA-WS, the Public Service Commission ("Commission") granted St. James' application for original water and wastewater certificates to serve the SummerCamp development in Franklin County. The planned location of St. James' wastewater treatment plant is located outside of the service territory that was originally requested by St. James and granted by the Commission in Order No. PSC-04-0755-PAA-WS. Because the wastewater treatment plant will be receiving water service from the utility, it is necessary to amend St. James' water service territory to include the wastewater treatment plant.
- 5. St. Joe has also decided to build an administrative building which will be located on St. Joe property across U.S. Highway 98 from the SummerCamp development. The administrative building will require both water and wastewater service from St. James.
- 6. Accordingly, through this Application, St. James is seeking to amend its certificated water and wastewater service territory to include the wastewater treatment plant and the administrative office building. The additional proposed territory requested herein will utilize less than twenty-five equivalent residential connections. ("ERCs")
- 7. In accordance with Rule 25-30.036(2), Florida Administrative Code, attached hereto as Exhibit "A" is the sworn written statement of Des O'Neill,, the Vice President of St. James confirming that (a) the proposed new territory includes a maximum of 25 equivalent residential ERCs within the proposed territory; (b) St. James confirming that upon investigations, and to the best of her knowledge, there is no other utility in the area of the proposed territory that is willing and capable of providing reasonable adequate service to the new territory; and (c) service to the proposed territories is necessary because service is not otherwise available.

8. Pursuant to Rule 25-30.036(3), Florida Administrative Code, within forty-five (45)

days of the completion of the required noticing provisions, St. Joe will file a completed application

with additional information as required by Commission Rule.

WHEREFORE, St. James respectfully requests that upon receiving confirmation that no

protest is timely filed to the notice of St. James' "Quick Take" Application, and upon St. James'

provision of additional information as required, the Commission:

A) acknowledge the amendment of St. James' Certificate Number 621-W to extend its

water service to include the territory located in Franklin County as described herein;

B) acknowledge the amendment of St. James' Certificate Number 534-S to extend its

wastewater service to include the territory located in Franklin County as described

herein;

C) Issue an amended certificate of authorization for the water and wastewater systems

reflecting the amended water and wastewater service territories; and

D) Grant such other relief as appropriate.


